Welcome to Dove Gospel - Multinational. Your privacy is important to us. This privacy policy explains how we collect, use, and protect the personal information you provide to us through direct interactions, such as filling out contact forms on our website or providing us with source material.

1. Important Information and Who We Are

Purpose of This Privacy Policy This policy aims to inform you about how Dove Gospel - Multinational handles your personal data when you interact with us directly, such as through our website, and outlines your privacy rights and how the law protects you.

Controller

Dove Gospel - Multinational is the controller and responsible for your personal data.

2. The Data We Collect About You

We collect, use, store, and transfer different kinds of personal data about you which we have grouped together as follows:

- Identity Data includes first name, last name, and title.
- Contact Data includes email address and telephone numbers.
- Usage Data includes information about how you use our website and services.

3. How Is Your Personal Data Collected?

We use direct interaction methods to collect data from and about you, including:

- Contact Forms: When you fill out contact forms on our website, we collect Identity and Contact Data.
- Consented Submissions: If you provide us with source material or other information after consenting to our terms, we collect the data included in those submissions.

4. How We Use Your Personal Data

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- Where we need to perform a contract we are about to enter into or have entered into with you.
- Where it is necessary for our legitimate interests and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal obligation.

Specifically, we use your data for the following purposes:

- To respond to your inquiries made through our contact forms.
- To process and manage your submissions and participation in our activities.
- To keep you updated about our services, if you have opted in to receive such communications.

5. Disclosures of Your Personal Data

We may share your personal data with external third parties in the following situations:

- Service providers who provide IT and system administration services.
- Professional advisers including lawyers, bankers, auditors, and insurers who provide consultancy, banking, legal, insurance, and accounting services.
- Authorities that require reporting of processing activities in certain circumstances.

6. Data Security

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used, or accessed in an unauthorized way, altered, or disclosed.

7. Data Retention

We will only retain your personal data for as long as necessary to fulfill the purposes we collected it for, including for the purposes of satisfying any legal, accounting, or reporting requirements.

8. Your Legal Rights

Under certain circumstances, you have rights under data protection laws in relation to your personal data, including the right to request access, correction, erasure, or transfer of your personal data.
