

This policy applies to all users engaging with Dove Gospel through our websites, training platforms, pastoral care systems, mission registration, live streams, and physical interactions.



The Data We Collect

We collect the following categories of data



Identity & Contact Data

Name, email, phone number, location, title, gender, and church affiliation.

Media Data

User-submitted content, testimonies, prayer requests, feedback, recorded group sessions, and participation in revival services.

Discipleship & Training Data

Course enrollments, certifications, mentorship participation, leadership progress.

Pastoral Care Data

Spiritual guidance notes, prayer logs, counseling support records (only with explicit consent).

Usage Data

Interaction with our websites, LMS, DG: Reach portals, media platforms, and social apps.

Financial & Donation Data

Giving history, tithes, and donation preferences (securely stored).

How We Collect Data

- Website forms and contact submissions
- DG: Reach and DG: LMS platform registrations
- Church membership directories and care systems
- Event sign-ups, mission applications, and discipleship forms
- User interactions through support services, email, and digital media

Why We Use Your Data

We use your personal data to:

- Equip and train leaders and disciples
- Facilitate global missions and events
- Provide pastoral care and follow-up
- Maintain accurate training and certification records
- Improve spiritual engagement and service participation
- Send mission updates, spiritual resources, and communications you've opted into
- Comply with legal obligations and stewardship requirements

We only process your information when:

- You've given explicit consent
- It's necessary for spiritual care or mission engagement
- There's a legitimate interest that aligns with your rights and expectations
- It fulfills our organizational responsibilities under biblical and legal governance

How We Share Data

We do not sell your data.

We may share it only with:

- Internal ministry teams for discipleship, prayer, or leadership development
- Regional Leaders and care teams as part of our mission and oversight
- Technology partners for secure platform hosting and analytics (e.g. DG: Reach, DG: LMS, Studio Streaming Gateway)
- Legal authorities, when required by law or to protect a member's safety



Data Security

We use industry-standard encryption, access controls, and secure cloud environments (DG: Cloud, DG: Identity) to protect your information across all platforms and services. Special pastoral data, prayer requests, and sensitive submissions are stored with heightened confidentiality protocols.

International and Spiritual Accountability

As a global revival movement rooted in biblical values:

- We hold ourselves accountable to God and the communities we serve
- Our leadership framework ensures data is handled ethically and transparently (see Leadership & Oversight)
- All leaders undergo data training and uphold our digital code of conduct via DG: Reach integration

Data Retention

We retain your data:

- As long as necessary for discipleship, mission participation, or training verification
- In accordance with legal obligations and spiritual record-keeping
- You may request deletion, correction, or export of your data at any time by contacting our Data Stewardship Team



You may at any time:

- Access a copy of your data
- · Correct inaccurate or incomplete data
- Withdraw consent or request deletion (subject to mission or legal exceptions)
- Lodge a concern with your local data protection authority or contact us directly

Children and Youth Ministry Data

For under-18s engaged in DG Youth programs or regional discipleship:

- Parental/guardian consent is always required for collection and processing
- Data is managed by youth coordinators under strict privacy practices
